STATE RELAY SELECTION POLICY

1. OBJECTIVE

The objective of the State Relay Selection process policy is to ensure the best possible teams are selected to represent the Lane Cove Swim Club (LCSC) at State AGE and OPEN swimming championships.

In the interests of the LCSC members, this policy also serves to provide clarity and make the selection process as transparent as possible.

2. POLICY PRINCIPLES

This document has been developed using the following principles and quidelines:

- The LCSC recognises that the professionals coaching our swimmers are in the best position to select the relay teams, relating to swimmers and their likely performance at a meet.
- Ultimate responsibility for team selection rests with the clubs Head Coach.
- A sense of fairness, responsibility and accountability.
- LCSC By Laws
- Swimming NSW and Swimming Australia common practice in relay selection.

3. CRITERIA FOR SELECTION

All swimmers wishing to be considered for selection in a STATE Club relay team must:

- Be a financial competitive member of the LCSC, and
- Have recorded an SNSW official time for from the current season or within the 3 months prior to STATE AGE or STATE OPEN.

4. SELECTION PROCESS STEPS

- 1. The LCSC Head Coach in affiliation with his coaching panel will determine the initial swimmers being selected for the relay teams.
- 2. The LCSC Race Secretary will provide the Head Coach with an up to date list of Meet Manager official results, swimmers will be ranked in order of approved times.
 - Times will be relevant to the event being swum, for example 4 x 50m freestyle relay selection will take into account the best 50m freestyle times of the swimmers being considered for selection.
 - Medley Relay will take into account the fastest swimmers in the stroke: Backstroke, Breaststroke and Butterfly.
 - Medley relay may also take into consideration 50m splits of the 100 Form strokes where necessary.
 - Swimmers should have attained individual times as recently as possible to the selection period.
 - NOTE: Relay splits are ineligible.
- 3. The initial relay teams will be formed by the 4 fastest swimmers, then changes may be made with justifications noted: These include but are not limited to:
 - All swimmers entered/attending STATE AGE or STATE OPEN for individual events are given priority to participate in relays.
 - Training Performance
 - Injury or any other reason for poor performance during the year
 - Any reason for extra ordinary performance during the year
- 4. The most appropriate swimmers will then be chosen for the relay teams, considerations for additional swimmers and reserves will also take place. Should two or more teams be entered the fastest team will be Team A the second fastest team Team B and so on.
- 5. Close attention will be paid to ensure that no swimmer has been overlooked.
- 6. Once the relay team is selected and swimmers notified, swimmers must confirm by e-mail to the Race Secretary by the specified date that they are able to swim in the relay. Failure to confirm availability by the specified date will result in another swimmer being selected.
- 7. When a relay team has been finalised and the team entry is complete no changes can be made unless a withdrawal occurs. Changes will be made at the discretion of the Head Coach ONLY.
